### **Coordination: WE NEED ONLY ONE MINUTE OF YOUR TIME**

56% of the people in Lewis County are registered to vote. Only 42% of the people in Lewis county voted in the 2010 election. We need to start taking action and informing our neighbors about what is going on in our county because our county officials do not inform us. There are about 20 major towns in Lewis County that need flyers hung up at; post offices, gas stations, groceries stores, churches, etc. We need everyone to do a little bit to get the word out fast when there is an event (public hearing) that people need to be aware of and attend in the masses. Thankfully we will never know what would have happened if the people did not alarm their neighbors about the public hearing in Morton about the watershed management plan.

- \* We are in need of volunteers to print off 1-5 flyers and hang them up at the stores they frequently shop or work at. A virtually effortless job and it makes a HUGE impact for our community. We have volunteers to hang flyers at the following Post Offices: Mossyrock, Salkum, Ethel, Morton, Randle. Please email me the locations you will hang flyers at so we know what areas are covered and what area not.

- \* We also need people to attend City Council meetings, Chamber of Commerce meetings, commissioner meetings, school board meetings, planning meetings, etc., so we can summarize the important happenings in a short email and inform people. If you know someone who attends meetings encourage them to contact me and give me a brief summary of what is going on so it can be discussed at the next meeting and get people informed.

### **Department of Ecology: WATERSHED MANAGEMENT - Senate bill to implement plan**

Dept of Ecology is still working on implementing watershed management thru the proposed WRIA's. Citizens are realizing how watershed management will affect their everyday way of life and take away their property rights. As citizens are waking up Ecology is ignoring the voice of the people by proposing legislation to the state with the same metering and monitoring proposals.
