- 4) Permission to Share My Information With “Accountable Care Organizations” Denied


The intent of the following commentary is to provide you with another view point from a property rights and unalienable rights perspective which you may not have regarding your business practices. While you are deluging my mail box and my town of Enumclaw trying to make a case “I am your first priority” and “thanking me for entrusting you with my health care”, with one hand while the other hand is robbing me of me and my fellow property owners of our homes and privacy.

I received a letter from Dr. Stephen Spare (enclosed) informing me that my paper medical records will be moved “onto a new electronic medical record” system for all Franciscan clinics and their 4 hospitals to access. This letter was not dated but I received it in June of 2013, I believe. Common courtesy would be to ask for my permission first before digitizing my personal medical history and please do not quote me the “law”, e.g. HIPPA.

I have not given you permission to digitize my medical records. Digitizing private medical information without my personal written approval goes against one of our most fundamental unalienable rights, the right to privacy. Digitizing private medical records for the sake of “patient safety” or “additional convenience benefits” does not justify making my family medical history available to your corporation or any other governmental cereal agencies who may order up my medical history in the future. My privacy is not for sale at any price or for any reason!

I request all my medical records (originals and copies) be removed from the Franciscan Health System and mailed to my home address above. I am terminating my business and my family business with the Franciscan Health System.

The insurance companies, health care companies, clinics, hospitals, etc. collude with and are pressured by all levels of government to reduce their costs at any expense to the sovereign state Citizen

customers. Private medical history shared with the doctor should never have been written down to begin with and should have been buried with the doctor when he passed on. Now these private comments and family history which were stuffed into a manila folder in a file cabinet in the doctor's office available to a few are systematically being digitized and made available to anyone with a "need to know". This is especially easy for those companies who share the same health care information system. It gets worse. I have been told the following comment by a leading Seattle based ophthalmology clinic, "if you don't wish to have your health history digitized, we will honor your wishes, however your insurance will not cover you anymore and you will have to pay cash". So we have a little extortion, a pinch of larceny, a dash of malfeasance, a teaspoon of misfeasance, a cup of colluding, a quart of malice aforethought, a pint of malice in law, a half gallon of malicious use of process just for starters to reconstitute an intent to save the colluding medical triangle some profit, i.e., 1) medical companies, 2) insurance companies and 3) government. Let me bottom line the last sentence to more profit for the private sector, more dam taxes for the public sector and less for me, the sovereign and free state Citizen, i.e. your ex customer . I see this all the time in the property rights taking arena.

Most "healthcare providers" are "forced" to buy into this constant taking of our private life and our unalienable rights for the benefit of the "common good", a.k.a. social fascism. However, a few brave patriot Americans practitioners and clinics are wisely opting out.

My Chiropractor long ago stopped taking insurance plans and charges a negotiated fee. Other chiropractic doctors I know are going to cash only monthly "health club" fee basis. Doctors, medical staff and especially the patients are sick and tired of the never ending invasive documenting of our private life at the demands of the intrusive insurance company and government regarding our family medical history and what is said in confidence to our doctor.

Furthermore, at least one doctor at the local Enumclaw Franciscan Medical Center has complained of patient overload. One doctor I know mentioned he had some 2700 patients. Your "for profit only" business model is turning private doctor patient relationships into a plantation operation which is immoral. This is a common negative symptom of socialized medicine.

I have waited my share of time for your overloaded doctors and overcrowded Enumclaw medical clinic much past the appointment time. I finally got around to discontinuing any business with you when I went in for appointment years ago and was a few minutes late. I was told by your front desk to rebook another time as I was a few minutes late. No mention of all the times I have waited over the year to see Dr. Clark, et al, of course.

I would venture to say St. Elizabeth and St. Francis are not looking kindly upon your Franciscan St. Elizabeth Hospital in Enumclaw, WA. Franciscan administration colluded with the greedy Enumclaw Municipal Corporation to eminent domain a number of beautiful old homes further transforming a residential neighborhood into a hospital parking lot complete with flashing parking lights. Enumclaw Municipal Corporation has a long history of bullying business owners and the sovereign state Citizens for its own growth at any expense including treachery. They work hand in hand with a couple of other bullies, King County Municipal Corporation and WA State.

Franciscan Hospital has further eroded our traditional community and the lives of these home owners whose homes were taken plus increased the traffic and noise for the local home owners. There is much level farm land south and east of Enumclaw which would better accommodate your new hospital without further rat packing our small quiet town. Please do not give me the long list of government excuses why you could not do this. I am sure St. Francis would have preferred the Franciscan Health System donate the old hospital for a community hall versus demolishing it for a parking lot, i.e. charitable acts. Also, I can't help but think that St. Francis strongly objects to the use of his name for the sake of your self righteous takings.

Also please take me off all Franciscan soliciting mailings. I find Franciscan Foundation comments like "Giving to Your Community" on their letter head hypocritical as well as "create healthier communities" on your web site. You do not create health by destroying homes, traditions and the privacy of local home owners. So called "compensation" through "eminent domain" is like compensation from the Mafia, i.e. take what we offer or else.

Also find attached (Franciscan NW Physicians Health Network) the "Consent to Change Personal Health Information Preference" form filled out denying any sharing of my private information which should never have been captured and document in the first place. My private life is not for you to have "the right care in the right place at the right time". I believe you have me confused with your inventory.

Finally, I have just had another experience alerting me to more invasion of my privacy. In a recent appointment with a doctor at Swedish Medical Group in Seattle, it appeared to me and my physician that my old records from Dr. Clark came up. Dr. Clark has retired and used to work at the Enumclaw Franciscan Medical Center. I never approved sharing my personal medical file with any other medical business; however this private information appears to now be in Seattle Swedish Medical Group. I have been told that Franciscan and Swedish use Epic information system so this seems to explain the sharing of my personal medical history. What I share with one doctor verbally does not mean I want it digitized and shared with every other doctor who happens to be on the same health information system.

You cannot manage or coordinate my health, my life, my personal family health history to improve your profits or share my information with anyone for any reason especially to "give me high quality care". This is called breach of trust and is also an invasion of one of my 70 unalienable rights called privacy. Insurance companies and government agencies cannot rightfully force you or me to document, digitize, share personal family history of any kind. When insurance companies and government and the medical non government organizations (NGO's) collude toward this end, this process violates the fundamental laws of land, i.e. Laws of Nature and Nature's God, the Declaration of Independence and the spirit and success of the first American Revolution.

I am all for profit and process improvement, however not at this price. I am deeply concerned about your hypocritical business practices.
