### infiltration

"We don't obviously put it past the likes of ISIL to infiltrate operatives among these refugees...That is a huge concern of ours."

## american benefits

Refugees go to the front of the line to receive benefits available to Americans, including: a furnished home; help with rent; healthcare; food, English language classes; building computer, financial literacy, and job skills; education for their children; social services and community support; and legal services toward residency and citizenship.

The Heritage Foundation has calculated that the 10,000 Syrians who would be admitted under the president's plan would eventually collect about \$6.5 billion in services over the next 50 years. Much of that would be borne by local communities.

## cost

The Center for Immigration Studies recently calculated that it costs twelve times as much to resettle a refugee in the U.S. as it does to care the same refugee in the Middle East. A family of four refugees will cost us \$257,482 over five years.

The Obama administration plans to expand the annual refugee admissions total from 70,000 in 2015 to 100,000 in 2017.

## process

Most Americans are not familiar with the resettlement process. The UN High Commissioner for Refugees picks most of our refugees and in the case of the Syrians they come from UN camps populated mostly by Muslims. Then, Voluntary Agencies (VOLAGS) work with the State Dept. in order to make the decisions about where to settle them. VOLAGS are paid millions of taxpayer dollars and are not required to inform local governments prior to resettlement and many do not track them after the first few months.

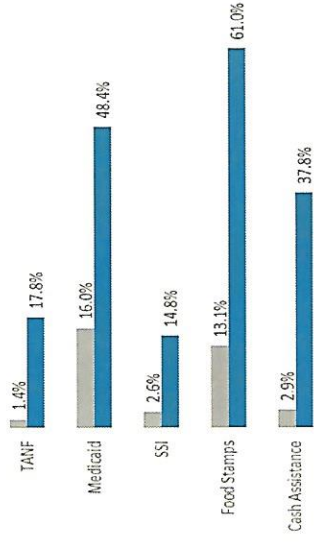

## refugee composition

According to the UNHCR, 62% of Mediterranean sea arrivals are men, while only 16% are women, and 22% are children. Moreover, ten nationalities make up the 88% of sea arrivals – only 50% of which are Syrian.
