Dear Friend of Liberty,

The U.S. government is granting citizenship to the children of Islamic terrorists. . . and this "suicide pact" signed by the White House, Congress, and the courts opens our nation up to even more attacks by the enemies of freedom and liberty, like Osama bin Laden's al-Qaeda terrorists, Hamas and Hezbollah.

Right now -- as you are reading this letter -- women are coming to the United States from Middle East terror-supporting countries for the express purpose of giving birth to a child and, due to a grave, misconstrued reading of the United States Constitution, gaining instant U.S. citizenship for that child, which can be exploited in the future for good or for ill!

And not only that. . . **unscrupulous American and foreign companies are aiding and abetting opportunists and our enemies by trafficking in this citizenship trade, seriously weakening our national security as they pocket their blood-stained fees.**

For the sake of our nation and our liberty, this dangerous, unconstitutional madness must be stopped now, and our chances of accomplishing just that have never been greater. In fact, U.S. Supreme Court Associate Justice Clarence Thomas says it's time to "re-examine, and begin the process of restoring, the meaning of the 14th Amendment agreed upon by those who ratified it."

Today, thanks to the present influx of constitutionalist candidates into Congress, the opportunity to right a serious, nation-damaging wrong is finally here. You see. . .

. . . for a hundred years Congress has compounded a serious judicial error of a ruling on the Constitution's 14th Amendment.

Ignoring the clear intentions of the amendment's writers, the U.S. Supreme Court has legislated from the bench by granting U.S. citizenship to millions of alien children not otherwise qualified. These include Mexican and Central American "anchor babies" that enable illegal aliens to gain legal residency here -- as well as qualify for access to myriad social services paid for by the American taxpayer -- and, now, Middle Eastern children whose parents are not only NOT "subject to the jurisdiction" of the United States, as the 14th Amendment requires, but in fact have sworn fealty to Islamic

terror organizations seeking the destruction of the United States.

This misapplication of a most critical section of the country's Supreme Law has rejected the words of Rep. John Bingham of Ohio, considered the father of the 14th Amendment, who said in 1866:

"[It] is simply declaratory of what is written in the Constitution, that every human being born within the jurisdiction of the United States of parents not owing allegiance to any foreign sovereignty is, in the language of your Constitution itself, a natural born citizen. . . ."

In its 1898 *United States v. Wong Kim Ark* decision, the Supreme Court nullified the wishes of Congress and the people of the United States, by ignoring the "jurisdiction" component of birthright citizenship. This bad decision set a precedent the SCOTUS has failed to put right, but that Congress can correct!

And it MUST, because that constitutional breach has now split wide open, granting hundreds of thousands of alien youth each year U.S. citizenship, even though their parents owe no allegiance to America.

What's more, unless this gross misinterpretation of the citizenship clause of the U.S. Constitution is soon rectified, our nation will continue to fill with those who deplete us economically, imperil our sovereignty. . . and even those who plot to see Islamic shariah law replace our Judeo-Christian tradition of natural law, and American blood flowing as jihad is waged from coast to coast. Please keep reading this vitally important letter to see what you must do to save America. . .

My name is Alan Keyes, and I'm writing to you today on behalf of Secure Borders Coalition (SBC); a critically important project run by Declaration Alliance. It was SBC, working with conservative patriot groups like the Minutemen Civil Defense Corps and others, who first sounded the early warning several years ago that America was suffering a literal border invasion by illegal aliens -- including international drug cartels, human and weapon smuggling rings, rapists and sex traders, and even terrorists -- and that our federal government was doing nothing to stem the dangerous flood.

We led the successful grassroots charge against Senate Bill 2611 which sought to grant amnesty to the vast majority of the more than 12 million "known" illegal aliens in the United States

(AND uncounted "unknowns"), PLUS open the door to millions more, including "guest workers" who steal jobs from American citizens and overwhelm our schools and health care systems.

And today **we're rallying patriotic Americans like you to protect the United States from the fifth columnists infiltrating and forever altering our country under the guise of misapplied "birthright citizenship."**

Unsurprisingly, there are those -- foreign and domestic -- who are taking advantage of this Supreme Court-created mistake for monetary gain or to target our nation for destruction.

And now a Turkish-owned luxury hotel in New York City is selling "birth tourism" packages to women from Muslim nations, enabling them to come to America to give birth and gain instant U.S. citizenship for their child.

What's more, the owner of the hotel chain is alleged to have ties to the radical "Gulen Movement" which not only promotes the Islamization of secular governments worldwide, it currently operates more than 85 charter schools inside the U.S. where it espouses pro-Islamist propaganda to American children!

In fact, the Gulen Movement helped set the table for the Islamization of Turkey -- once a reliable NATO ally now aligning with terror-state Iran -- that has turned this major country into a potential threat to American security.

Turkey today is led by a radical Islamist who, as mayor of Istanbul, said, "The mosques are our barracks, the domes are our helmets, the minarets are our swords, and the faithful are our army." *And this is the nation sending women to the U.S. for the sole purpose of giving birth on our territory to gain American citizenship for their children.*

We at SBC have been saying for years: our law enforcement agencies have a hard enough job monitoring suspected Islamic terrorists on our soil without idiotic complicity by the courts.

But it is sheer lunacy to allow tens of thousands of men and women with ties to anti-American Muslim groups to take up residency in the United States, where they can plot their jihadi attacks against us, just because our government has neither the courage nor constitutional knowledge to understand that the Supreme Court's mistaken Ark ruling does not mean the 14th Amendment grants

citizenship solely based upon birth in America.

When the amendment was proposed and debated in 1866, Senator Lyman Trumbull -- one of the key figures in its drafting -- acknowledged that there were **two** components to birthright citizenship: first, the child must be born in the United States. Second, the child -- through his or her parents -- must be "subject to the jurisdiction" of the American government.

(According to Senator Trumbull and several subsequent Supreme Court rulings, that phrase means the child's parents must owe uncompromised allegiance to the United States, and the U.S. must accede to their status relative to government authority.)

Other contemporaries of the 14th Amendment debate agreed. **Congressman James F. Wilson stated that "children born on our soil to temporary sojourners or representatives of foreign Governments" were not citizens, and Congressman John A. Bingham said children born in the U.S. "of parents not owing allegiance to any foreign sovereignty" are natural born citizens.**

Congress recently heard testimony that over 2/3s of all births in Los Angeles public hospitals, and nearly 10% of all births nationwide, are to mothers here illegally. There is no constitutional impediment to Congress ending the birthright citizenship grant to those whose presence here is both without the U.S. government's consent and in violation of its laws.

And that, my friend, would exclude *illegal* aliens whose loyalty rests with their foreign homeland, AND all non-citizen Muslims who have any connections whatsoever to Islamic groups calling for the overthrow of our constitutional republic or working for the implementation of unconstitutional shariah law.

Such Muslims are not seeking a new life as Americans, men and women desiring to leave behind the cruel inequality and bigotry of medieval practices to assimilate into the U.S. population like millions of immigrants before them. These are denizens of foreign nations -- bringing with them hostile alien customs and beliefs -- with a goal of changing our society, even violently, to meet their Islamic religious and political goals.

Specifically, *they seek the overthrow of our constitutional republic, bought with the blood of patriots over the past 234 years.* In its stead they plot to establish a global caliphate under shariah, the radical Islamic law that governs every aspect of

life through harsh, inequitable regulations and punishments.

And they want that control to extend to YOU, not just to "believers" -- theirs is a socio-political program of conquest.

These radical Muslims are taking full advantage of our government's refusal to properly interpret what the framers of the 14th Amendment made perfectly clear: children of parents who owe allegiance to a foreign nation or power, although born on U.S. soil, are NOT citizens of the United States.

My friend, it is absolutely critical that we, as patriotic Americans who want to preserve our constitutional liberties, rise up as one against this egregious attack on our sovereignty. We must also instill in our young people the knowledge of what the U.S. Constitution really means, that it may be defended.

And now Supreme Court Justice Thomas and Rep. Steve King (R-Iowa), chairman of the House Subcommittee on Immigration, have opened that door for us by calling for a reexamination of the original intent of the 14th Amendment.

Enclosed with this letter is a postcard to Congressman King. It calls upon him to follow through on his public statements, and demand the Subcommittee initiate an immediate review and hearings to restore the 14th Amendment to its original Constitution-honoring purposes.

For only with this reexamination can we get our immigration and citizenship policies back under control. Without restoring the intent of Senator Trumbull and company, America can never hope to stop the influx of illegal aliens and other foreigners seeking the destruction of our constitutional republic.

So please sign and mail your postcard today. We must inundate Congressman King's office with demands, lending him the public urgency he needs to bring this issue forward in Congress.
