Subject: Montana CSKT Water Compact Alert

I just received the email below and attachments above (both same letter in Word or PDF) from a local Montana rural property owner friend.

The attached is a 3 page letter from Lawrence Kogan, the principal of the Kogan Law Group in New York, N.Y. who has been involved in helping the Montana rural property owners and irrigators especially on the Flathead Reservation, NW Montana with the help of Elaine Willman, MPA. They toured Montana in 2016 I believe making a strong case against the unfairness of the Confederation of Salish & Kootenai Tribes Water Compact deal made with Montana State and the federal government. Elaine is a direct descendant of the Cherokee tribe and her husband is of Shoshone ancestry and direct descendant of Sacajawea. She has authored two books titled "Going to Pieces", The Dismantling of the United States of America as well as "American Tribal Tyranny", how federal Indian policy secretly monies up elected officials forcing American taxpayers to fund all annual operating needs of the BIA and 574 wealthy tribal governments."
