- The states are involved in gambling and the sale of alcohol which makes my point further.
- These Municipal Mafia organizations are dressed up in street clothes while they back themselves up with a growing police state.

I have one neighbor who is paying one third of his pension for his property taxes. I have two other neighbors who were forced to pay over \$20,000 in extorted larceny to King County DDES land use fees. This is what I paid for the original cost of my 10 acres back in 1976. There are hundreds of examples of persecuted property owners on my site which is a representative sample of millions of property owners in America who are waking up to this barbaric form of legal and financial fiction yet nothing changes. Some of my best friends say they do not care about property rights or they are happy just the way it is. Can you believe it!

King County government and its vast network of 3,141 other counties and thousands of city muni corporations in America combined with the 50 states plus territories and D.C. Inc. are clearly a criminal enterprise.

- Once you shift your perspective to the real nature of the municipal hierarchy takings you will awaken.
- Political party and religious affiliation should be as insignificant on these municipal corporation boards as on private corporations in a true and honest free society.
- When someone tells you it would be worse if one political party or the other dominated the board of a corporation, you have a greater awareness now to see why this should not even enter the equation.
- In other words, the municipal corporations rightfully have no more power if not less than a private corporation.
- A true and honest political corporation is very limited in its charters.
- It provides a utility infrastructure for basic services at the free will and free choice of its natural born Citizens who are not taxed and are only billed for direct services provided.
- This is how it used to be until the crooks took over your mind and media.
- Nobody should be concerned about ones faith, race, political party on the board of a true and honest public corporation just as in a private corporation.
- The Municipal corporation "business" model can easily be eliminated completely and replaced by private service management groups who bill the Citizens for direct services used only


We all know what has happen. The private and public corporations have merged and sharked out the private and public sector of at least 60 other countries in the world including America.

In April, Pete von Reichbauer (<http://www.kingcounty.gov/vonreichbauer.aspx>) cut a backroom deal with the Democrats (specifically Larry Phillips, the senior Democrat on the Council) and sold his vote in exchange for a lollipop in 2012 King County budget (in King County parlance, a lollipop is a pet project or pork barrel earmark). All 5 Democrats on the Council (Larry Phillips, Larry Gossett, Bob Ferguson, Julia Patterson, and Joe McDermott) were always going to vote to unilaterally jack up car tab taxes, but they needed one sell-out Republican to get it passed. (After reading this: "King County Council member Larry Phillips, meanwhile, tells PubliCola he's optimistic that the Democrats on the council will manage to sway at least one Republican vote", we did some investigating and learned about Phillips' backroom deal).

On April 25th, we sent everyone an email alerting you that one of the four Republicans on the King County Council (Jane Hague, Kathy Lambert, Pete von Reichbauer, or Reagan Dunn) had sold their vote -- we did not name von Reichbauer. In response to your emails and phone calls, each of them, including von Reichbauer, denied cutting the deal and emphatically opposed unilaterally imposing ANY increase in car tab taxes without a vote of the people. Here was what Pete von Reichbauer sent to the media and to constituents:

"In his second Inaugural Address, President Ronald Reagan asked: If not us, who...if not now, when? If the Washington State Legislature will not listen to the taxpayers the King County Council should, and I for one have listened to my neighbors and I will NOT vote for the proposed car tab. Thanks for taking the time to ask me if I was going to vote for the fee increase. Pete von Reichbauer"

On Monday, the day of the Council's vote, after returning from recess and in a very Perry Mason-like moment, PVR announced that "new information has been brought to my attention" and then asked for a 20 minute recess. It was all fabricated theatre. By hyping it in this way and postponing the vote until August 15th, he was able to get even more lollipops.
