Since Auburn was a central feature of this communication I will try to respond especially when so many different facts were distorted. These are totally different events separated by time and intent.

When I first came on the Auburn City Council in 1997 there was an area west of downtown bordered on the west by State highway 167, on the east by the Union Pacific Railroad and the interurban trail, Main Street on the south and 15th Street NW on the north. Water in that area moves to the west. When SR 167 was built in the sixties it created a dam to the flow of water across the valley. Over the next forty years water continued to gravitate to the west up against the dam. Homes and farms along that area continued to get wetter and wetter. The state and county and Auburn were all sued several times and lost because houses and farms were being flooded. We could not find any way to stop the water coming in so instead we began to look at bringing the water in, treating it and then sending it into what would amount to an environmental park for all to use. We are one of the poorer cities in the county so tax payer's money isn't a possibility and have instead asked that environmental groups contribute, that environmentally based companies locate in the area and contribute. Instead of a taking we've tried to find a way to prevent other property owners in that area from losing their properties and help correct a problem we had no hand in creating

The comment about the Property Fairness Initiative and grabbing people's land is again distorted. Since 2005 the Chamber of Commerce, the Auburn Downtown Association and community groups including the faith community were involved in an effort to provide zoning and comprehensive plan changes for our city. We took no land by these changes and of the 'hundreds of acres' most of the changes were about changing isolated pockets of industrial surrounded by either commercial or residential and changing that use to the surrounding use. Under these changes an owner of an industrial property can keep that business forever. They can sell it to another firm doing the same type of business – again forever. They can expand the use by going through the City Council. The only restriction is if they want to try to sell that industrial property to a different industrial use.

Separately in our downtown the City of Auburn had purchased land at market value on several different downtown blocks. The city paid market rate for the land and did so with the full support of the downtown community. This was done without any threats but instead to show the city's commitment to downtown

On a block next to City Hall we did begin condemnation on several old taverns as the city- the Auburn Downtown Association, the Chamber of Commerce and others planned for a City Plaza and Annex. No more than that.

As far as traffic cameras go for red light traffic enforcement – we have two intersections with cameras. We would like to have more but right now there are just two. We aren't going to apologize for bad drivers. Our response as a city to those people who don't live or work in Auburn that are making up more than 50% of those getting tickets – don't run a red light in Auburn. We are tired of putting our men, women and children at risk because you won't obey one of the simplest traffic laws.

Fed Up With Being a Stepford Property Owner Enumclaw, WA

Funding

The City is currently reviewing several opportunities for funding. Funding sources vary from federal and state agencies to non-profit organizations and foundations. While there appears to be many sources to choose for funding assistance, the City reviews opportunities that will best fit the objectives and goals of the Auburn Environmental Park.

Eco-Tourism and Partnership Discussion

A Rainier Audubon Society spokesperson described the partnership opportunities associated with the project and presented a check to the City in support of the project. With 500 members, the Rainier Audubon Society represents a significant source of financial and grassroots support. Birding enthusiasts are the largest group of environmental tourists in the country, totaling 71 million and spending \$29.2 billion annually on the hobby and \$9.4 billion on trip-related expenses. In Washington State, more money is spent on birding than hunting, and 47% of residents participate in some sort of birding activity.

Recent changes in the funding of these projects at the State and Federal level has allowed for more options. The State of Washington is currently looking for local projects that could used for the concept of creating wetland mitigation banks. Auburn Environmental Park, because of its magnitude, qualifies as a potential wetland mitigation bank. Further research is ongoing in determining the feasibility of making the Auburn Environmental Park a wetland mitigation bank. At this time, it's clear that wetland mitigation banks have been difficult to establish in the past and only one currently exists within the State of Washington (Snohomish River Valley). Discussion with the regulatory community and others continue in hopes that this process can be streamlined and made available to organizations without expending an exurbanite amount of resources.

Birding Tower

Birding towers have been used in many bird habitat areas to provide a longer view over tree vegetation. The features within these towers can vary greatly.

Information Kiosk

An important part of the Auburn Environmental Park is providing educational information to visitors. Kiosks provide a means of providing basic information about features and activities around the site.

Paved Trail

An asphalt paved trail 8-feet wide is typical in parks. It consists of a small amount of fill covered with a small amount of crushed rock then 2-inches of asphalt paving over the top. This is usually relatively easy to install and maintain. These types of trails will be limited within the Auburn Environmental Park so as to decrease the need for mitigation.

Project Background

The Auburn Environmental Park (AEP) Project is an innovative project that seeks to create open space in an urbanized area while offering opportunities for economic development, water quality improvement, stormwater detention and flood control, fish and wildlife enhancement, public education, and recreation, including hiking trails and bird viewing amenities.

Project Area

The project area is bounded by 15 th Street NW to the north, the Interurban Trail to the east, West Main Street to the south and State Route 167 to the west. The vicinity west of SR 167 encompasses a segment of Mill Creek and is being studied for inclusion in the next phase of the AEP Project.





Process and Next Steps

Auburn has completed a feasibility study and begun early consultation with agencies, community groups, and the public. During the next year, the City will develop a master plan for the AEP Project while simultaneously looking for grant and other funding resources.

The next steps will include detailed planning and project engineering, ongoing grant writing and fundraising, ongoing development of public-private partnership opportunities, and more land acquisition. Once the master plan is complete and funding is secured, Auburn will be ready to begin implementing the project.

The City hosted a public kick-off celebration on June 16 th, (click here for meeting summary) introducing the AEP Project and inviting community members to participate on a Technical Advisory Committee (TAC). The TAC will meet periodically to guide project staff as they develop the master plan.


