I just passed your news onto my email list plus the House and Senate for what good that does. I also emailed the two red light manufactures who are involved in this crime. Their sites seem to be quite slow and busy.

These crooks all work and live in the cities and orchestrate their illegitimate positive paradigm taxing and taking schemes upon private property owners to perpetuate themselves. The vendors making this equipment go against every fundemental law of the land including the constitutional law, common law, natural law and God's law by selling weapons that invade all of our unalienable rights, see attached. The city mayors & councils are so greedy, they can't tell the difference between a traffic problem and a planning problem, whereby they rat pack the cities along the mandate of the UN Agenda 21.

These urban governments are stealing our wages, homes, land, privacy and trespassing upon our vehicles and our rights all the time. Then they pretend its Constitutional. Then to further convince themselves they are not stealing private property, they create more legal fiction progressive regulations that can only apply to commercial legal fiction corporations .

They pretend these commercial legal fiction regulations also apply to the natural born sovereign and free state CITIZENS. There are no common or natural laws that authorize the regulation or taxation of the natural born free and sovereign state CITIZENS OR ANY OF THEIR PRIVATE PROPERTY. If there were laws such as they pretend, we would be slaves, would we not?

The urban governments are responsible for much of the unconstitutional tax system. Read the long tax list below that never existed a hundred years ago, but with the invention of legalized theft upon property owners by these urban government predators.

These crooks have no clue the entire tax system upon the natural born & sovereign state Citizens is unconstitutional. This urban tax taking scheme has been ruled unconstitutional by the high courts more than once. Property taxes cannot be applied unless they are apportioned evenly to every man, women and child and even then that goes against the "Laws of Nature and Nature God, i.e. the naturals laws. Income taxes AND sales taxes are all indirect excise taxes that cannot be imposed on the natural born Citizens. They can only be applied upon legal fiction corporations including government employees.

Red lights, ticketing, coding, fining, permitting are only legitimate on municipal government corporations and legal fiction corporations.

I have been researching this cycle taking for the last 4 years after the local King County takings of our property rights.

The government multisided consortiums are profiting from this extortion, e.g. the teachers unions, government employees, political parties, and the corporate fiction groups like these red light companies. Whether it is central bankers, central government or centralized state teachers association they are complicit in illegitimately perpetuating forced takings upon our private property. Again there is no founding our organic laws that authorize this. All the common and natural laws and God's laws forbid stealing of private property. Stealing is when you are robbed by force to pay.

The only legitimate form of government revenue is a very limited indirect tax and the revenue of the sale and lease of state owned natural resources. I am being told the City of Enumclaw charges a 3% business tax. This is a Constitutional indirect tax. The City is of Enumclaw is corrupt however and extorts the private property owners by taxing them based on a unconstitutional property tax in addition to forcing numerous private and business owners off their property using the misapplied "eminent domain".

The only reason "eminent domain" got into the Constitution was because of elite colonial land speculators and then it was applicable to the territories only. It was never meant to be applied to private property home and land owners in the several states. The cities, counties and state governments may only legitimately ask for an indirect tax on corporations and customs duties for those governments living on the coasts or borders and the sale and lease of any public lands within their existing limits.

There are many private property owners drug through the crooked court system, in prison and jail and even some who have committed suicide, many now have been foreclosed upon and have no homes, no jobs, no lives. All because of the urban criminal tax and taking paradigm to reward themselves and their buddies so they may continue to steal from the innocent property owners.

Urban political systems are built upon an intentional fraudulent scheme. Ignorance of the laws is no excuse. How many time have you heard that? What's good for the goose is good for the gander.

Urban government and those groups who abuse them, like the 40,000 some teachers in Washington State, purposely turn a blind eye on the fundemental laws while our homes, land and savings are foreclosed upon US. The central CONsortiums which cause most of the takings of our private property create a paradigm whereby they refuse to support themselves and create a free market for their services. The city governments and the primary, secondary and academia have become delusional thinking they deserve to not compete and to be paid for only 9 months out of the year.

Then they orchestrate a taking of private property that goes against all the laws of the land and the Laws of Nature and Nature's God by stealing private property, e.g. property taxes to extort home and land owners into a fascist system. Then when they get in trouble and the extortion does not pay them enough, they strike or demand more from the same groups who are stealing from the same poor private property owners.

CON..gress who ignorantly allows the bailouts of these ill-gotten groups create continual rounds of inflation, devaluation and increase in unconstitutional taxes thereby perpetuating a boom bust cycle ad infinitum. This has been going on for 232 years, believe it or not.

This cycle of taking (e.g. taxing and regulating private property) is not unlike a rebound effect of continually dosing yourself with a drug. The more you take them more you want until you are an addicted drug user ultimately destroying yourself. Indirect taxes are an addiction. Direct taxes are a crime.

This illegitimate taxing and taking of private property is a death cycle to Americans and America and it is led by the city fathers & councils who have become so perverted they ignore all the fundemental laws of the land. This situation is the ultimate hypocritical double standard whereby the city government officials who are the financial cesspools of government, then turn on their masters and strangle them to death via uncountable legal fiction creations, e.g. eminent domain, zoning, ordinances, acts, codes, draining our rural lakes for their water supplies, locking up our own land, homes, roads, vehicles, livestock while buying up more private property and turning it into elite parks and stealing right of ways from private property owners so they can create a trail on a railway without compensating the property owner while creating an attractive nuisance for them and all the adjoining and nearby property owners.

This back stabbing process is perfected by the city, county and state cereal departments, e.g. park and code departments.

The Mayors of Auburn, Enumclaw and near every city and county and state agency in Puget Sound have been doing this for decades, even centuries while the private property owners are ruined. This is totally criminal. There is no original law to support this and it is all legal fiction creations of municipal corporations all the way up the D.C., including the UN and the three central banking families in America and the 5 in Europe. All roads lead to the Bank of England and the Bank of Rome.

The cities, counties and state government officials are responsible and accountable for all these travesties upon innocent home owners and wage earners. All private property owners, rural and urban, await the day of judgment for these crooks.

Cities, counties and states have no authority or jurisdiction over the lives and private property owners including their homes, land, wages, vehicles, livestock and the buffer areas around their private land and homes. We are NOT EMPLOYEES OF THE CITIES, COUNTIES OR THE STATE. WE ARE SOVEREIGN AND FREE. We are ruled by God and the Common and Natural Laws as we so choose. We are accountable to no man or government.

This is an classic example of how our sacred boundaries of private property have been broken down. You cannot trespass upon a man's land, home, vehicles, wages, privacy or any of the some 60 certain enumerated unalienable rights. See list attached above. Just as you cannot grope, touch or take from anyone without their express permission, you cannot directly tax them or take any of their private family property. "Photo Red companies top anti-985 donors" reads the jump on today's homepage of the Spokesman Review. Over 1/4 of the total money raised from I-985's opponents (\$160,000) has come from a red light camera company: Signal Electric \$40,000 so far. "Arizona-based American Traffic Solutions" has donated \$10,000 so far.

But their political contributions to the No campaign weren't business-related; they contributed for altruistic reasons.

As the story notes: "Jerry Vosberg, vice president of Signal Electric, said the company's \$40,000 contribution was not motivated by the potential of lost profit."

The same selfless reason explains the other contribution: "Josh Weiss, spokesman for American Traffic Solutions, said the company contributed money in solidarity with communities it serves."

How admirable. Note the rhetoric from these companies matches what we hear from politicians: it's not about the money, it's all for the "greater good."

Just because these companies profit millions of dollars every year from these cameras, that's not why they're in business. Just because cities profit millions of dollars every year from these cameras, that's not why they're putting them up. Just because EVERY camera contract has a provision that allows the company to move the cameras to a different intersection if revenue isn't being maximized, no, no, you've got it all wrong, it's not about the money.

I-985 removes the profit motive for photo red light cameras and photo speeding cameras. As a result, we read comments like this from

Wenatchee's mayor: "(Mayor Dennis) Johnson said the city's incentive to install cameras is gone if I-985 passes." Oops, looks like the 'no' campaign hadn't distributed its talking points in time for that Wenatchee World story.

As today's Spokesman Review story notes: Money from red light cameras would be a small portion - likely less than 10 percent - of the money raised for the traffic decongestion fund under Eyman's proposal. He (Eyman) argues that Spokane's warning that the camera might have to be unplugged is another sign that red light programs have been created to generate revenue. "Under our initiative, they have no profit motive for red light cameras," Eyman said. "Now they will truly analyze which intersections truly does it help and which ones does it maybe hurt, and only put up the cameras at those intersections where it will actually make things better."

Well said.

As reported by the Washington Post: The District's red-light cameras have generated more than 500,000 violations and \$32 million in fines over the past six years. City officials credit them with making busy roads safer. But a Washington Post analysis of crash statistics shows that the number of accidents has gone up at intersections with the cameras.
