"..the common part of speech is listed first....this order is changed in those cases where it is desirable to group related meanings .."

In circles of property owners, constitutional rights people, gun owners, tax payers, anyone who government takes from, the word rape is associated most commonly with meanings 3., 6., & 7. i.e. the order of these meanings are changed and grouped accordingly to serve to communicate that We The People are being raped of our freedoms.

My assignment on the staff of the Bordentown Reformatory was compiling the statistics of the case histories of each inmate. If you think that only women and children are assaulted, I wish I had a copy of that study to show you. I will spare you the details. I have forgotten most of it. It was a shock to this

Montana cowboy. I was about 20 years old. This was my first lesson in the horror of big cities and their prisons.

While one can intellectually differentiate the various definitions of this ugly word, here is some detail I won't spare your of our "plight".

This is what this four letter word means to us regarding the Random House definitions 3, 6 & 7.

- Taking private property while plundering the State and U.S. Constitution
- Creating land use acts that force, seize, take and plunder all of our private property and land use rights.
- Creating never ending legislation that forcibly plunders, seizes and takes all of our natural God given rights as free citizens
- Intentionally ignoring corrupt election officials and acts, while they force, take and plunder the peoples choices
